2024 SCHOOL SWIMMING SCHEME

Dear Parents/Caregivers,

The Department of Education and Training School Swimming Scheme is an intensive learn to swim program which develops water confidence and provides students with basic skills in water safety and survival. The scheme is conducted over ten (10) consecutive days by qualified instructors.

Students who have not reached a satisfactory standard of water safety and survival skills, and are unable to swim 25m confidently unaided in deep water, are eligible to participate in the School Swimming Scheme.

The scheme focuses as a priority on beginning or non-swimming students in Years 2-3 then students that are beginning or non-swimmers in Years 4-6.

This year we have been allocated <u>60 places</u>. Lessons will be conducted at Wentworthville Pool. Travel to and from the pool will be by bus. Places are allocated on a 'first in' basis and places are limited. A \$50 deposit is required to secure your child's place. Final payment must be made by 20 September.

The scheme will continue daily for two weeks. <u>There will be no charge for the swimming lessons</u>. The cost covers daily transport to and from the pool and pool entry. The total cost of this program will need to be paid prior to the program starting. **Refunds are not available.**
